

## AGREEMENT

between

Facultad Latinoamericana de Ciencias Sociales Sede Ecuador (FLACSO ECUADOR)

and

GRADUATE SCHOOL OF GLOBAL STUDIES, DOSHISHA UNIVERSITY, JAPAN

Facultad Latinoamericana de Ciencias Sociales Sede Ecuador (FLACSO Ecuador) and the Graduate School of Global Studies, Doshisha University, wishing to enhance the relationship between the two institutions by developing closer academic and cultural exchanges in the areas of graduate education, research, and other activities, have agreed hereby to cooperate and work together toward the shared goal of internationalization of higher education through the terms of this agreement.

1. The areas of cooperation will include any program offered by either institution, which is desirable and suitable for the development of cooperative relationship between the two institutions. Any specific program shall be designed and executed upon the mutual consent and approval of the institutions signing this agreement. Such programs shall include, but not be limited to, the following:
  1. Exchange of faculty
  2. Exchange of students
  3. Joint research projects
  4. Joint seminars and conferences
  5. Exchange of research materials and resources.
2. The specific terms of cooperation shall be discussed and agreed in writing by the authorized officers of both parties prior to the initiation of any particular program or activity, and will be set forth in a separate agreement..
3. FLACSO Ecuador designates Professor Fredy Rivera Vélez, Research Coordinator, International Relations Program and Graduate school of Global Studies, Doshisha University designates Professor Masanori Naito, Dean of Graduate School of Global Studies, as their respective officers responsible for the full implementation of any program or activity under this agreement.




4. The differing viewpoints and interpretations of this agreement shall be settled amicably by mutual consultation or negotiation.
5. This agreement shall come into effect on the date when the representatives of both institutions affix their signatures to this agreement, and shall be valid for an initial period of five (5) years, subject to revision or modification at any time by mutual written consent. Either party may terminate this agreement at any time by providing a written notice to the other party no less than six (6) months prior to the termination. However, any projects that have commenced at either institution by the date of termination may be completed. The institutions will confer concerning the renewal of this Agreement six (6) months prior to its expiration.

This agreement is prepared in English and two (2) original copies of this agreement are produced. Both copies are authentic. As witness to their consent to this agreement, the appropriate authorities hereunto provide their signatures.




