

AGREEMENT

between

**Facultad Latinoamericana de Ciencias Sociales Sede Ecuador
(FLACSO ECUADOR)**

and

Center for Cross-Cultural Studies, Kyung Hee University (CCS, Republic of Korea)


The Facultad Latinoamericana de Ciencias Sociales Sede Ecuador (FLACSO Ecuador) and the Center for Cross-Cultural Studies, Kyung Hee University (CCS, Republic of Korea), with the purpose to enhance the relationship between the two institutions through developing closer academic and cultural exchanges in areas of graduate education, research, and other activities, have agreed hereby to cooperate and work together towards the shared goal of internationalization of higher education through the terms of this agreement.

1. The areas of cooperation will include any program offered by either institution, which is desirable or suitable for the development of cooperative relationship between the two institutions. Any specific program shall be designed and executed upon the mutual consent and approval of the institutions signing this agreement. Such programs shall include, but not be limited to, the following:
 1. Exchange of faculty
 2. Exchange of graduate students
 3. Joint research projects
 4. Joint seminars and conferences
 5. Exchange of research materials and resources.
2. The specific terms of cooperation shall be discussed and agreed in writing by the authorized officers of both parties prior to the beginning of any particular program or activity and will be set forth in a separate agreement.
3. FLACSO Ecuador designates Dr. Fernando García, Coordinator of Relationship to the Community, and the Center for Cross-Cultural Studies, Kyung Hee University designates Dr. Jungwon Park, Director of Center for Cross-Cultural Studies, as their respective coordinators responsible for the full implementation of any program or activity under this agreement

4. The differences viewpoints and interpretations of this agreement shall be settled amicably by mutual consultation or negotiation.
5. This agreement shall come into effect on the date when the representatives of both institutions affix their signatures to this agreement and shall be valid for an initial period of five years, subject to revision or modification at any time by mutual written consent. Either party may terminate this agreement at any time by providing a written notice to the other party no less than six months prior to the termination. However, any projects commenced at either institution by the date of termination will dully be completed. The institutions will confer concerning the renewal of this Agreement six months prior to its expiration.

This agreement written in English and two (2) original copies of this agreement are produced. Both copies are authentic. As witness to their consent to this agreement, the appropriate authorities hereby provide their signatures.
